

TERMS OF SALE

ALL ORDERS ARE SUBJECT TO ACCEPTANCE BY RANE CORPORATION.

*Terms: 6% 30 days, net 45 days from date of shipment. A 6% discount will be allowed on product if payment made by cash, check, ACH, or wire is received within 30 days FROM DATE OF SHIPMENT. A 3% discount will be allowed on product if payment made by credit card is received within 30 days FROM DATE OF SHIPMENT. Otherwise payment by any method is due within 45 days FROM DATE OF SHIPMENT. Invoices not paid within 45 days will be considered past due and are subject to a 1.5% monthly finance charge (18% per annum). No discount will be allowed if previous invoices are past due. Extension of credit terms is subject to credit approval. Orders are F.O.B. Mukilteo, WA.

QUANTITY DISCOUNTS: The quantity discounts shown on this price sheet apply to total quantities on single purchase orders only. Accessories such as security covers and transformers will not apply to final quantity nor do they have quantity pricing applied to them. Scheduled deliveries will not apply to order quantity unless each delivery meets the quantity required to qualify for the lower price. No add-ons will be accepted to any previous purchase order once any part of said purchase order has been shipped. No re-billing to reflect lower pricing due to larger quantities will occur due to any changes in invoices already posted by Rane Corporation. Cancellations which change the total order quantity from 4+ pieces to 1-3 pieces will be billed accordingly. Additional discounts on large quantity orders may be available. Please consult the factory for information.

PAID FREIGHT: Surface freight will be paid by Rane Corporation on any single purchase order totaling \$5000.00 or more (dealer price before any discount). If cancellation of any portion of a shipment occurs prior to delivery of the minimum \$5000.00, any paid freight incurred by Rane Corporation will be billed to dealer and is due upon receipt of invoice.

Rane reserves the right to assess a re-stocking fee of 15% of invoiced price on all products returned to Rane for credit.

Suggested retail prices are just that, suggested. Actual selling prices are determined by the individual Rane Dealer. All products, specifications, features and prices are subject to change without notice.
